Rules to Live By

- 1) Licensing requires the VFW National Home for Children campus be a weapon free, alcohol free and smoke free campus. Please plan accordingly.
- 2) Possession or use of illegal substances is forbidden.
- 3) Riders will insure their vehicle is in a safe mechanical condition prior to the ride.
- 4) Riders will operate their vehicle in a safe manner not posing a hazard to themselves or other riders.
- 5) Riders and passengers will not consume alcohol at any time except at overnight locations and then only from the time of arrival until 10:30 p.m.
- 6) Riders and passengers will not behave or dress in a manner that might bring discredit upon the Veterans of Foreign Wars, the VFW National Home for Children, or VFW Post 6974.
- 7) Riders and passengers will comply with appropriate directions from the ride officers.
- 8) The rules are necessary to insure the safety of all riders and passengers. Violators will be asked to leave the Ride and not return. No refunds will be given.

Note: Indiana and Michigan require all riders to wear a helmet.
